Minutes of last meeting

1. Matters Arising

Mark Watson plant hire have agreed to dig out the area for the play park and put a ramp in. Clerk to contact play equipment provider to get an up to date quote and also PCC regarding the grant. Councillors agreed to have a site meeting at 7pm before the next meeting on Monday 11th July.

6 PCC report

Cllr D Harries not in attendance but had sent round an email detailing the position on

various issues:

“Just a quick update that the Leader has been re-elected at the recent AGM and he has selected a cabinet - none from the North and no Welsh Speaker which is disappointing and I have raised this with him - we are one Pembrokeshire and the North cannot be ignored.

I chased up the CAT for Cefn Coed which I believe you now have.

Speed limits - Scleddau - I have spoken to Paul Davies MS and he has confirmed that the Welsh Government are reviewing this again which means that nothing will change for another year - are there any other considerations or change they need to account for? I know people along the Scleddau to Fishguard straight raised the speed limit with me as well asking if it could be 50 all along that route - not sure if this is something you have discussed before?

Also residents in Panteg asked if they could look at the speed limit along that road as well - has this been raised with the Community Council.

Barham Road - i have raised the condition of the road and waiting to hear back. I am trying to get an update on the Water issue.

Trecwn playing fields - This is with PLANED and I have asked the officer at County Hall to chase for an update.

I am waiting a date to meet up with one of the managers at The Valley who invited me to a meeting and the Election Team in County Hall have asked me to raise the issue of a polling station at their premises with him again.”

7 Any other business

7.1 A Phillips – found out who had put the seat in Cefn Coed. It was put there by Mr Hawkins in Cefn Coed. Clerk to send a letter thanking him. Proposed D Haden, seconded A Phillips.

7.2 D Williams reported that the Jubilee weekend at the pub had gone very well and they had raised a further £176 towards the cost of fireworks in November, with a total of around £250. There were about 15/16 kids that attended the children’s party.

7.3 D Haden reported on Barham Road. There had been a meeting between PCC, WW and Planed on 8th June. Young Bros had put a price in to do the mains, but it was more than WW expected and they were also not interested in doing individual connections, so they are now at a stalemate. Until another contractor is found that is willing to do individual connections they are back to square one.

7.4 A Phelps proposed a donation to Fishguard AFC for the use of the hall and facilities. £150 proposed, seconded by J Miles. Clerk to send a letter and cheque.

7.5 Clerk to get some quotes for a noticeboard on legs. Clerk to check back on emails with Mervyn Hawkins and previous clerk.

7.6 Some residents had contacted J Miles regarding the speed of traffic and being able to pull out of their drive safely. They would like to use a mirror but it is thought they would need to contact Highways for permission. Clerk to contact Highways to find out.

7.7 A Phillips – clerk to report fly tipping on bridal path.
