**Minutes of last meeting**

The minutes of the last meeting were signed as a true record save for the date of the meeting was incorrect and it should have read A Phillips and not A Williams. Proposed by J Miles and seconded by D Haden. All were in favour.

**1. Matters Arising**

- 1.1 Asset Transfer – Sally Price contacted Helen Hodges, but was still waiting an update. It was discussed that about the Community Council not being responsible for the fencing. It was agreed to revisit this when the lease had been finalised.
- 1.2 Website – D Haden had received a quote for the building of the website. The quote was £200. It was agreed to proceed and accept the quote. Both Sally and Dylan would liaise with the gentleman building the website.
- 1.3 YFC Hall – It was noted that the last stages of work are being carried out and that the hall will be opened on the 12<sup>th</sup> July. It was agreed to hold future Community Council meetings at the YFC Hall from September 2025.
- 1.4 VE Day Celebrations – It was noted that celebrations were held at Jordanston Church. Bells rang and a Beacon was lit. J Miles explained that windows had been decorated with information memorabilia and that this would have been kept up until the following Sunday.
- 1.5 Wesley Memorial – Mr Urwin had been in touch outlining that there would be a talk taking place at Theatr Gwaun on Tuesday 13<sup>th</sup> May. Some discussions would be made on the preservation of the Wesley memorial and oak tree in Trecwn. A Anderson outlined that he would try and attend the presentation.
- 1.6 Letter to the First Minister – Cllr Harries noted that he had received a response from the First Minister and it outlined that the speeding limits were under review.

#### 6. PCC report

Proclamation Ceremony – It was noted that a Proclamation Ceremony would be held at the weekend in Narberth for the forthcoming Eisteddfod.

Social Care – It was noted that the Local Authority was looking at preventative measures on social care matters. The Local Authority have been looking at possibly opening 2 new residential homes for the elderly in both Fishguard and Tenby.

#### 7. Any other business

- Weeds are overgrown on the path in the village.
- The previous issue of drains needing clearing has still not been resolved.
- The Water works at Barham road has been completed and signed off. It was noted that the bottom half of Barham Road needs resurfacing. It was unknown who owns that road. Cllr Harries advised that he would contact the legal team in County Hall to review the matter. The Chair thanked both D Hadan and Cllr Harries for their involvement of sorting the water issues out and asked to pass on his thanks to the workmen who carried out the project. It was discussed that the road between Llangwarren and the Water Bridge, the edge of the road was breaking away and very unstable. An email would be sent.
- It was understood that Barham Road School would be going up for sale. It was believed that the building was a grade 2 listed building.
