Minutes of last meeting

Proposed D Williams, seconded A Phelps. All in favour.

1. Matters Arising

1.1. Bank account - Proposed D Haden, seconded D Williams that we move bank accounts from Barclays to Natwest. Four signatories required - Clerk, D Haden, M Raymond and A Phelps. Clerk to apply online.

1.2. Barham Road - D Haden reported that Planed have got involved again. There is an Zoom meeting on 02/11/21 with PCC, WW and Barham Road Association to discuss moving forward again. Negotiations have recommenced between WW and PCC. The current situation is that residents are connected to the depot supply. The current proposal is that residents connect to DCWW but that the depot does not connect to DCWW and is to remain on private supply. This would cost around 7-8k per property. The other option is re-doing the line from the depot, funded by PCC and then reclaimed from residents.

The water leak outside the old school has fixed, paid for by the resident/owner.

1.3. The bus stops have not been pressured washed, this has now been put back until spring Proposed D Williams, seconded A Phelps.

1.4. As per the interview early this evening, the new councillor will be co-opted onto the council at our next meeting.
