Minutes of last meeting

The minutes of the last meeting were signed as a true record proposed by A Anderson and seconded by M Scrimshaw. All were in favour.

1. Matters Arising

- 1.1 Asset Transfer – There had still been no response from either the solicitor or Pembrokeshire County Council in relation to the amendments to both leases. Cllr Harries would make contact with The Chief Executive, Will Bramble, to try and move the leases along. S Price would also try to make contact with Helen Hodges via telephone as there has been no responses to the emails sent.
- 1.2 Website – All information had been collected by S Price and sent to B Collins who was building the website. It was hoped that the website would be up and running by the next meeting.
- 1.3 Wesley Memorial – Mr Len Urwin attended the meeting to discuss the talk that was held at Theatr Gwaun recently and the progress on the preservation of the memorial and oak tree. It was noted that a tree preservation order could not be put on the oak tree. He stated that the next stage would be around the access and how it can be maintained. It was noted that the land was privately owned, by possibly three land owners. Mr Urwin would keep in close contact with D Haden as a contact of the community council.

2. Agenda Items

- 2.1 Vacancies – It was noted that there had not been any applications for the 2 vacancies that was advertised recently. It was agreed to reshare the adverts via the Scleddau Community Council Facebook page and Noticeboard.
- 2.2 Fishguard AFC – An email had been received from Fishguard AFC asking for a letter of support from the Community Council to demonstrate the need for an air source heat pump to be installed. After deliberation it was agreed to write a letter of

support. S Price would contact S James to find out who the letter needs to be sent to.

- 2.3 Kids Cancer Charity – A letter had been received from this charity, who is based in Swansea, asking for donations for those 27 families in Pembrokeshire that has a child affected by cancer by providing Respite Breaks, Play Therapy and a full range of services. M Scrimshaw proposed a donation of £200, this was seconded by J Miles. All were in favour.

- 2.4 One Voice Wales – An email had been received outlining that representation from all community councils should attend area committee meetings. After deliberation it was felt that these were not relevant to Sclleddau, however, it would be looked at what the purpose and benefits of these meeting were, and how they could assist the community.
