Minutes of last meeting

The minutes of the last meeting were signed as a true record proposed by D Haden and seconded by D Williams. All were in favour.

1. Matters Arising

- 1.1 Asset Transfer – Helen Hodges, the solicitor representing the Community Council in relation to the 2 Asset transfers attended the meeting to go through both leases. A number of items were highlighted that needed to be amended. These amendments would be discussed with Pembrokeshire County Council and it is hoped that the draft leases will be altered to reflect this.
- 1.2 Wind Turbine – It was noted that planning for the wind turbine was passed.
- 1.3 Website – Further information would be obtained and brought back to the next meeting.
- 1.4 YFC Hall – It was noted that the YFC were still awaiting a fire certificate from the Fire Service. This would allow public to access the building. It was agreed to continue using Tregroes until a certificate had been received.

2. Agenda Items

- 2.1 One Voice Wales National Awards Conference – For information outlining that the awards conference would be taking place on 30th April 2025
- 2.2 Section 6 Report – Clerk outlined that she had attended a webinar early that day as all community and town councils are required to report on how they have met the statutory biodiversity and ecosystems resilience duty.
- 2.3 Sandy Bear – Further to a letter being received from the Charity outlining the support provided to those children within the Parish, it was agreed to donate £250 to the cause. This was proposed and seconded by D Haden and J Miles.
- 2.4 VE Day – It was noted that there would be celebrations within the community and that Bells would be rung at Jordanston Church as well as the Beacon being lit.
- 2.5 Zurich Insurance – The quotation for the insurance for this year was £241. D Haden proposed to proceed and D Williams seconded.
- 2.6 Community Council resignations – It was with great sadness that both A Phelps and A Williams had both decided to step down from their roles on the Community Council. M Raymond thanked both gentlemen for their commitment and hard work

they had given to Scloddau Community Council over the years. Clerk would now contact the elections office to advertise the vacancies.

- 2.7 Wesley Memorial – A letter had been received from a member of the public wanting advice relating to the current owner of the site where the memorial was located. It was thought that Matt Creed was possibly the site owner. It was agreed to write a letter to Matt Creed asking for further information.

3. Planning applications

Capel Sion, Chapel Road – proposed new outbuilding and various landscaping works. After deliberation it was proposed and seconded to agree the planning application.

Church Cottage, Letterston – Development for alterations to roof and attached outbuilding. After deliberation it was proposed and seconded to agree the planning application.
